### EMT CONTRACT

**Contract is being made between EMT student, \_\_\_\_\_,  
who is an employee DMFPD and DMFPD Board.**

- 1. DMFPD agrees to pay for student's EMT instruction in class, and ride outs as outlined in class in the amount of \$0000.00.**
- 2. DMFPD agrees that student will be able to study on DMFPD grounds.**
- 3. The student will be covered under insurance for test and ride outs with other ambulance service as prescribed by Pueblo Community Collage.**

### STUDENT'S OBLIGATIONS TO DMFPD

**EMT student agrees to the following;**

- 1. If student does not pass nor complete the EMT-I course provided by Pueblo Community College, the student agrees that all money paid for the EMT course and ride outs, for this student, will be repaid to the district.**
- 2. The EMT student agrees to work for DMFPD for two (2) years after taking and passing and completion of the EMT course and taking and passing the National exam.**
- 3. The EMT student also agrees that in the event they resign from DMFPD within two (2) years after taking the state exam for EMT class, they will repay the District all money for all of the lessons, ride outs that DMFPD has paid out for this student.**
- 4. In the event the student leaves for another agency and uses their skills as an EMT, they will repay the district the full amount of money that was paid by the DMFPD for this student.**
- 5. The EMT student agrees that if the chief of the department dismisses them for any reason, or the EMT student leaves or resigns of their own accord, they will pay back the DMFPD any prorated money left in the two (2) year contract. (IE: If the student fulfills one (1) year of working for DMFPD and is**

terminated or quits, they will pay back DMFPD for the one (1) year that was left on their contract.)

- 6. The EMT student agrees to work shift and hours prescribed by the chief of the department.
- 7. EMT student agrees to continue to work as a B.L.S student while taking the EMT course.
- 8. EMT student and DMFPD agree that employment is AT-Will, with the DMFPD.

**CULMINATION**

DMFPD agrees to pay for EMT class and everything associated with the class. EMT Student \_\_\_\_\_ concurs to the outlined above requirements.
